3. Right to Terminate the Process

- i. KRC reserves the right to terminate the Request for Proposal (RFP) process at any time, without providing any specific reason. KRC does not make any express or implied commitments regarding the outcome of this process, nor does it guarantee that it will lead to a business transaction with any party.
- ii. This RFP does not constitute an offer by KRC. The bidder's participation in this process may result in KRC selecting the bidder to engage towards execution of the contract.

4. Submission of Response/Proposal

The bidders should submit their responses as per the format given in this RFP in the following manner:

- i. Response to Pre-Qualification Criterion

- ii. Technical Qualification Criterion
- iii. Financial Proposal

Prices should not be indicated in the Pre-Qualification Proposal or Technical Qualification Criteria Proposal but should only be indicated in the Commercial Proposal in the format given in e-procurement portal.

5. Site Inspection

Bidders are advised to inspect the site and its surroundings where this equipment is to be installed and satisfy them before submitting their tenders. A bidder shall be deemed to have full knowledge of the work whether he/she inspects it or not and no extra charges consequent on any misunderstanding or otherwise shall be allowed.

6. Acceptance

During the bidding stage, the firm, supplier, or dealer may arrange the demonstration of the equipment or material for its quality and specification check at KRC's premises or online at its own cost if required by KRC's official before placing the supply order.

The bidder shall provide such packaging of the equipment as is required to prevent damage or deterioration during shipment or equipment. The bidder shall promptly repair or replace any equipment that is damaged during transit. The packaging, marking, and documentation within and outside the packages shall also comply strictly with the requirements. The bidder shall insert in each case a packing list, fully itemized to show the case number, contents, gross and net weight, and cubic measurement.

If it becomes necessary for the Bidder to replace or renew any defective portions of the Equipment under this clause, the provisions of this clause shall apply to the portions of the Equipment so replaced or renewed until the expiration of six months from the date of such replacement or renewal or until the end of the warranty period, whichever may be the later. If any defects are not remedied within 15 days from the date of communication thereof or within such other specific period as may be allowed by the KRC in his discretion on application made to that effect by the Bidder, the KRC may proceed to carry out the work at the Bidder's risk and expense, but without prejudice to any other rights which the KRC may have against the Bidder in respect of such defects.

7. Training to KRC

Bidder shall provide training to the personnel nominated by the KRC at respective locations to enable them to have sufficient knowledge and skill to effectively manage, maintain, use and operate Equipment and to change/modify programs during installation, warranty and O&M period.

On-site training during the installation of the Equipment shall be arranged by the Bidder. Arrangement of all training materials such as manuals, drawings, brochures etc. shall be the responsibility of the Bidder.

8. Preparation and Submission of Proposal

8.1. Proposal Preparation Costs

The bidder shall be responsible for all costs incurred in connection with participation in the RFP process, including, but not limited to, costs incurred in conduct of informative and other diligence activities, participation in meetings/discussions/presentations, preparation of proposal, in providing any additional information required by KRC to facilitate the evaluation process, and in negotiating a definitive contract or all such activities related to the bid process.

KRC will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

8.2. Language

The Proposal should be filled by the bidders in English language only. If any supporting documents submitted are in any language other than English and Hindi, translation of the same in English language is to be duly attested by the Bidders. For purposes of interpretation of the documents, the English translation shall govern.

8.3. Pre-Bid Conference

- a) The Kamla Rai College, Gopalganj shall hold a pre-bid meeting with the prospective Bidders as per information given in the schedules of events.
- b) The Bidders will have to ensure that their queries for pre-bid meetings should reach the point of contact (Nodal Officer) in written form either mail (kamlaraicgpi@gmail.com) or in form of letter(to principal of kamla rai college, near arrar mor, gopalganj- 841428) in company's letter head only as mentioned in the schedule of events above. No queries will be entertained after prescribed date and time. Virtual link will be uploaded on the website prior to the pre bid meet.

8.4. Evaluation process

The Technical Evaluation Committee shall be constituted by the KRC. The Technical Evaluation Committee may request meetings with the Bidders to seek clarifications on their proposals.

The Technical Evaluation Committee reserves the right to reject any or all proposals on the basis of any deviations.

Each of the responses shall be evaluated in accordance with the criteria and requirements specified in this RFP.

8.5. Tender Opening

The Proposals submitted by the Bidders will be made available online at the designated time and date, as specified in the schedules of events by the officials of KRC, or any other authorized officer. Such officials shall be present in the presence of the Bidders or their representatives at the time of opening. In the event that no Bidders are present, the tender will still be opened as scheduled.

The representatives of the Bidders should be advised to carry a valid identity card or a letter of authority from the tendering firms to establish their bona fides for attending the opening of the proposal.

8.6. Tender Validity

The offer submitted by the Bidders shall be valid for a period of 180 days from the date of submission of the Tender.

8.7. Tender Processing Fee:

All Applicants are required to pay a non-refundable tender processing fee, as applicable through online.

8.8. Earnest Money Deposit (EMD):

- An earnest money deposit (EMD) of Rs.1,00,000 (one lakh) must be submitted through the e-payment mode (i.e., NEFT/RTGS/Credit Card/Debit Card) on the E-Proc2 Portal or in the form of a bank guarantee. This deposit must be submitted well before the expiration date or time for the submission or uploading of the offer or bid. Failure to do so will result in the rejection of the bid.
- The EMD will not accrue interest and will be refundable. In the event that the selected bidder fails to submit the required performance guarantee or execute the agreement, the EMD will be forfeited.

Note: -

- Notwithstanding anything contained in this tender document, technical assessment shall be made at the sole discretion of college and its decision shall be final and not challengeable.
- In case of a tie in the L1 price, the work will be awarded based on the highest average annual turnover submitted in the tender and in case of further tie , decision of the college will be final
- Conditional bids will be summarily rejected.

9.2. Financial Bid Evaluation

The Financial Bids of technically qualified bidders will be opened on the prescribed date in the presence of bidder representatives. In the event that no bidders are present, the tender will still be opened as scheduled. Any conditional bid would be summarily rejected.

10. Appointment of vendor

10.1. Right to reject Proposal

KRC reserves the right to accept or reject any proposal at any time, and to annul the tendering process or public procurement process and reject all proposals prior to awarding the contract. This action does not incur any liability to the affected bidder or bidders, nor does it obligate them to be informed of the grounds for such action.

10.2. Performance Guarantee

The KRC will require the selected bidder to provide an irrevocably, unconditionally Performance Bank Guarantee within 14 days of the notification of award. The value of the guarantee should be 5% of the total cost of ownership. The guarantee should be valid for 48 months from the date of award, covering the delivery schedule, the O&M period (12 months), and a 3 years annual maintenance service (AMS) period. The selected bidder will be responsible for extending the validity date and claim period as needed due to non-completion of the supply order and warranty period.

If the selected bidder fails to submit the performance guarantee within the stipulated time, the KRC may cancel the order at its discretion without prior notice. The college will invoke

the performance guarantee if the selected vendor fails to discharge their contractual obligations during the specified period or incurs any loss due to the vendor's negligence in carrying out the supply order implementation as per the agreed terms and conditions.

In addition, if the selected bidder fails to submit the performance guarantee within the stipulated time, the KRC will initiate the process for confiscating the performance security from the L1 bidder and awarding the contract to the next L2 bidder at the same rate as the L1 bidder.

10.3. Signing of Contract

Post submission of Performance Guarantee by the successful bidder, KRC may enter into a contract, incorporating all clauses, pre-bid clarifications and the proposal of the bidder between KRC and the successful bidder or can also directly give the purchase order to the selected bidder.

1. Sub-Contracting, Consortium and Joint Ventures

Consortium, Joint venture, AOP (Association of Persons), subletting, Subcontracting and Outsourcing will not be allowed.

2. Transition And Exit Plan:

- The Selected Vendor shall ensure a smooth transition in the event of mutual consent to terminate or foreclose the contract. In addition to contract cancellation, the College reserves the right to impose appropriate penalties and liquidated damages on the selected agency.
- Proper documentation of all risks during the transition stage is essential to ensure a smooth transition without any service disruptions.

11. Terms and Conditions: Applicable Post Award of Contract

11.1. Right to Terminate the Process

KRC reserves the right to cancel the contract entered with the selected bidder and recover expenditure incurred by KRC under the following circumstances: -

- a) If the selected bidder breaches any of the terms and conditions of the bid, they will be held accountable.
- b) A bidder may voluntarily or otherwise liquidate their assets.

- If the selected bidder fails to complete the assignment as per the timelines prescribed in the RFP and the extension if any allowed, it will not be a breach of contract.
- KRC reserves the right to cancel the order in the event of delay and forfeit the bid security as liquidated damages for the delay.
- If the deductions for liquidated damages exceed 10% of the total contract price.
- In case the selected bidder fails to deliver the quantity as per the delivery schedule,

KRC reserves the right to procure the same or a similar product from alternate sources at the risk, cost, and responsibility of the selected bidder.

11.2. Liquidated Damages

- a) Despite KRC's right to cancel the order, liquidated damages for late delivery will be charged at 1% (One percent) of the undelivered portion of the order value per week. This charge will be subject to a maximum of 10% of the order value.
- b) Liquidated damages for late commissioning will be charged at 1% of the order value per week. This means that for every week of delay, the damages will increase by 1%. The maximum amount of liquidated damages that can be charged is 10% of the order value.
- c) Kindly be advised that the aforementioned delays in delivery and commissioning are mutually exclusive and shall be levied accordingly.
- d) KRC reserves the right to recover these amounts by any mode, such as adjusting from any payments to be made by KRC to the bidder. Liquidated damages will be calculated on a weekly basis.

11.3. Limitation of Liability

- a) Neither party shall be held liable to the other for any special, indirect, incidental, consequential (including loss of profit or revenue), exemplary, or punitive damages, whether in contract, tort, or other theories of law, even if such party has been informed of the possibility of such damages.
- b) The total cumulative liability of either party arising from or relating to this contract shall not exceed the total amount paid to the Bidder by the Client under the applicable statement of work that gives rise to such liability (as of the date the liability arose). However, this limitation shall not apply to any liability for damages arising from (a) Willful misconduct or (b) Indemnification against third-party claims for infringement.

11.4. Penalty

- a) The Bidder shall diligently fulfill its obligations under the agreement signed with KRC, in a professional and ethical manner.
- b) The Bidder shall diligently execute all activities in accordance with the timelines and parameters outlined in the Request for Proposal (RFP) issued by KRC. In the event of any non-compliance, KRC reserves the right to impose penalties as per the terms and conditions specified in the RFP. The penalties for delayed delivery of the laboratory equipment will be deducted from the payment to the vendor at a rate of 1% of the project cost per week, subject to a maximum penalty of 10% or the termination of the contract.

11.5. Dispute Resolution Mechanism

In the event that any dispute between the Parties fails to resolve through negotiation in the manner outlined above, the same may be exclusively resolved through arbitration. Either Party may submit a dispute for arbitration within 20 days of the failure of negotiations. Arbitration shall be conducted in Bihar in accordance with the provisions of the Arbitration and Conciliation Act, 1996, or any subsequent statutory modifications or re-enactments thereof. Each Party to the dispute shall appoint one arbitrator, and the two arbitrators shall jointly appoint the third or presiding arbitrator.

The provisions of this RFP shall be governed and construed in accordance with the Laws of India, and the exclusive jurisdiction of the Courts in Gopalganj, Bihar, shall apply to this matter.

11.6. Force Majeure

Force Majeure is herein defined as any cause, which is beyond the control of the selected bidder or KRC as the case may be which they could not foresee or with a reasonable amount of diligence could not have foreseen and which substantially affect the performance of the contract, such as:

- Natural phenomenon, including but not limited to floods, droughts, earthquakes and epidemics.
- Acts of any government, including but not limited to war, declared or undeclared priorities, quarantines and embargos
- Terrorist attack, public unrest in work area provided either party shall within 10 days from occurrence of such a cause, notifies the other in writing of such causes.

The bidder or KRC shall not be liable for delay in performing his/her obligations resulting from any force majeure cause as referred to and/or defined above. Any delay beyond 30 days shall lead to termination of contract by parties and all obligations expressed quantitatively shall be calculated as on date of termination. Notwithstanding this, provisions relating to indemnity, confidentiality survive termination of the contract.

11.7. Fraud Or Corrupt Practices

- a) The Bidders must uphold the highest ethical standards during the bidding process, after issuing the Letter of Intent (LOI) or Work Order (WO), and during the Agreement's duration. Despite any contrary provisions in this RFP, the KRC may reject a bid, withdraw the LOI or WO, debar the bidder for a year from future KRC projects, or terminate the Agreement without liability to the bidder if it determines the bidder engaged in corrupt, fraudulent, coercive, undesirable, or restrictive practices. In such cases, the KRC shall forfeit and appropriate the bid security or performance security as agreed-upon compensation and damages for the Authority's time, cost, and effort in evaluating the bids.
- b) Without prejudice to the KRC's rights under this clause and the LOI/WO or

Agreement, if a bidder is found to have engaged in any corrupt, fraudulent, coercive, undesirable, or restrictive practice during the selection process or after issuing the LOI or executing the Agreement, they shall be ineligible to participate in any KRC tender or RFP for a year from the date of such finding.

c) For this Section, the following terms will have their respective meanings:

- **\"Corrupt practice\"** means offering, giving, receiving, or soliciting anything of value to influence a public official's action during a project's tendering and execution.
- **\"Fraudulent practice\"** means representing or omitting facts or disclosing incomplete facts to influence the selection process.
- **\"Coercive practice\"** means impairing or harming or threatening to impair any person or property to influence their participation or action in the selection process.
- **\"Undesirable practice\"** means establishing contact with a person connected to or employed by KRC for canvassing, lobbying, or influencing the selection process, or having a conflict of interest.
- **\"Restrictive practice\"** means forming a cartel or making an understanding with bidders to restrict or manipulate a fair competition in the selection process.

2. The Bidders shall observe the highest standard of ethics during the Bidding Process and after the issue of the Letter of Intent (LOI)/Work Order (WO) and during the subsistence of the Agreement. Notwithstanding anything to the contrary contained in this RFP, or in LOI/WO or the Agreement, the KRC may reject a bid, withdraw the LOI/WO, debar the bidder for a period of one year from participating in the future projects of the KRC or terminate the Agreement, as the case may be without being liable in any manner whatsoever to the Bidder, if it determines that the Bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practices. In such an event, the KRC shall, without prejudice to its any other rights or remedies, forfeit and appropriate the Bid Security or Performance Security as mutually agreed genuine pre- estimated compensation and damages payable to the Authority for, inter alia, time, cost and effort of the Authority, in regard to the RFP, including consideration and evaluation of such Bidders Proposal.

3. Without prejudice to the rights of the KRC under Clause above and the rights and remedies which the KRC may have under the LOI /WO or the Agreement, if a Bidder, is found by the Authority to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Selection Process, or after the issue of the LOI /WO or the execution of the Agreement, such Bidder shall not be eligible to participate in any tender or RFP issued by KRC during a period of 1 (one) year from the date such Bidder is found by the KRC to have

directly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case may be.

4. For the purposes of this Section, the following terms shall have the meaning here in after respectively assigned to them:

- I. **“Corrupt practice”** means the offering, giving, receiving, or soliciting of anything of value, pressurizing to influence the action of a public official in the process of tendering and execution of the project.
- II. **“Fraudulent practice”** means aim is representation or omission of facts or disclosure of incomplete facts, in order to influence the Selection Process.
- III. **“Coercive practice”** means impairing or harming or threatening to impaired harm, directly or indirectly, any person or property to influence any person's participation or action in the Selection Process.
- IV. **“Undesirable practice”** means (I) establishing contact with any person connected with or employed or engaged by KRC with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Selection Process; or (ii) having a Conflict of Interest.
- V. **“Restrictive practice”** means forming a cartel or arriving at any understanding or arrangement among Bidders with the objective of restricting or manipulating a full and fair competition in the Selection process.

12. Technical Requirements

- i. The successful Bidder shall procure the Lab Equipment as required from a reputed OEM. The Bidder shall note that the specification provided is the minimum requirement and can supply better specification if required. The Bidder shall supply all components as per requirements of the RFP. The Bidder shall be responsible for supply of the Lab Equipment and installation at site.
- ii. All Lab Equipment proposed by the bidder shall be licensed to Kamla Rai College, Gopalganj and will be the property of Kamla Rai College, Gopalganj. The Bidder has to prepare and submit a delivery report including details of all components supplied. The delivery report will be validated by Kamla Rai College, Gopalganj.
- iii. The Lab Equipment provided by the Successful Bidder shall meet all the Service Level requirements as mentioned in the RFP. While the basic Bill of Material will not change, any change in the BOM specification will be done only to provide a higher specification.

- iv. Successful bidders will be expected to bring all the installation equipment and tools required for the installation of the Equipment. All the work shall be done in a conscientious manner as per the OEM guidelines and best industry practices. The Equipment shall be subjected to inspection at various stages. Local regulation/codes shall be followed at all times. The Successful Bidder shall follow all Safety Regulations and Practices at the time of installation and implementation.
- v. The Successful Bidder shall not cause any damage to buildings/installation site and property and will perform restoration to the original condition to the satisfaction of Board authorities, if any damage occurs.
- vi. Kamla Rai College, Gopalganj shall perform the acceptance test (AT) ensuring that all the Lab Equipment supplied are performing as per the specification. Kamla Rai College, Gopalganj would issue certification of completion after verifying availability of all the Lab Equipment.
- vii. The bidder should provide all relevant documentation including:
 - Original Manuals, Data Sheets, Installation Documents and any other documents relevant to the hardware and peripherals supplied by the Bidder.
 - Documentation should be provided by the selected Bidder on a regular basis as and when desired by Kamla Rai College, Gopalganj during the entire period of Contract.

14. Details on Scope of Work

This Request for Proposal (RFP) seeks to identify and select an agency responsible for supplying laboratory equipment, installing it, and providing maintenance services to KRC. The objective of this RFP is to enhance the academic potential and vibrancy of the college by supporting and consolidating research endeavors.

14.1. Scope of Work:

- 1. Supply and installation of Laboratory Equipment:** The selected agency will be responsible for providing standard laboratory equipment that meets the requirements and specifications of Kamla Rai College. Selected agency will be also responsible for installation of complex machine and electronic equipment the equipment should be the latest branded models manufactured with 100% new OEM parts. All products supplied should be part of the current production as of the date of tender award. Refurbished equipment is not acceptable.
- 2. Annual Maintenance Services (AMS):** The selected agency will be responsible for providing annual maintenance services for the supplied laboratory equipment for a period of one year. Subsequently, AMS will be provided for an additional three years, as per the rates quoted in the financial bid and stipulated in the final signed contract.
- 3. Compliance with Specifications:** The selected agency must demonstrate equal or better compliance with the specifications of the bidding document. It is not acceptable to mention “Best Quality,” “Good Quality,” or “Superior Quality” in the bid. Instead, the make and brand of the items quoted should be provided.

Important Note:

- Bidders may substitute alternative standards or brand names in their bids, provided that they demonstrate equal or better compliance with the specifications of the bidding document.

15. Equipment:

15.1. Installation of Lab Equipment

No additional charges for installation or demonstration will be levied beyond the quoted prices.

15.2. Warranty period, maintenance & technical support

The warranty period of all capital items shall commence after receipt of the items in good working condition and from the date of its satisfactory installation and acceptance test by the consignee.

The warranty period and validity of Performance Guarantee shall be extended for the period of delay in satisfactory installation and delay in warranty services.

All the Capital items / Lab Equipment shall be covered under one year onsite comprehensive warranty with Maintenance & Technical support services.

15.3. Deliverables & Timelines

The Bidder should deliver the Lab Equipment, commissioning and Installation within Four weeks from the date of issuance of purchase Order.

16. Payment Terms and Procedure

- 30% of the Contract amount towards the respective laboratory shall become payable by the KRC through SNA-SPARSH upon completion of setup configuration and test acceptance within 30 days.
- 20% of the Contract amount shall become payable by the KRC through SNA-SPARSH after the submission of a Successful completion Certificate from the user within 30 days.

Note: As this is part of PM USHA, all regulations and procedures of PM-USHA and Bihar Financial Rule will be adhered to during the payment process. Additionally, the regular directions issued by BSHEC will be strictly followed.
